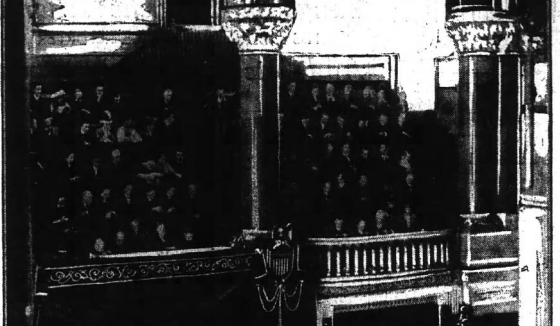

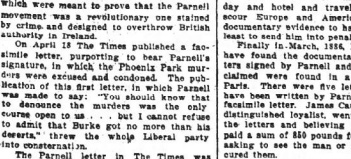

FLOOD OF QUESTIONS REGARDING INCOME TAX

Queries Are Being Prepared by the Treasury Department. Blanks to Be Sent Out.

Washington, September 29.—The treasury department is preparing for a flood of questions concerning the new income tax, resulting from the fact that the first returns are not due until October 1, 1914. One of the first steps taken to get general information before the public will be to distribute income tax blanks through post offices, internal revenue offices and other federal agencies. However, the fact that he does not receive a blank or a request to pay the tax will not exempt a taxable person from the penalty of the law.

"The treasury regulations soon to be prepared will make clear to every taxpayer the requirements of the law and its application to income derived from various sources," said Mr. Hill. "Any person who keeps familiar with his business affairs during the year should not have any difficulty in executing his tax return."


